Questions for the NYSCA

The following concerns and questions were recently posed to the NYSCA and were answered by the Executive Officers, Membership, Insurance, and Legislative committees. They have been paraphrased for the sake of this article. As always we are committed to serving our members and the Chiropractic profession, so we appreciate new insights. These types of conversations are regularly updated to our current NYSCA members and we are stronger together.

Why can't NYSCA provide accreditation for CEUs? The 180day timeline and required paperwork are a hindrance.

A: There is a 90-day approval period for Chiropractic Continuing Education (CCEs), a fair amount of paperwork, and an annual fee for an accrediting body. The State Board for Chiropractic sets those standards, so if there is a request for change it would have to be addressed with them. The NYSCA has limited staff and resources required to solely uphold all the requirements. Northeast College of Health Sciences (formerly New York Chiropractic College) has been generous in helping fulfill these requirements in a timely manner and they require an additional 30-day period for processing paperwork. This totals 120-day lead time. We welcome new ideas for CCEs and the NYSCA administrative staff can facilitate getting approval through Northeast, which is good for up to three years for a specific lecture.

Can NYSCA help reduce the time insurances companies can retract payments from 24 months down to 6 months?

A: There is current legislation called the "Look Back Bill" that would reduce the time for retroactive audits down to 90 days. The NYSCA authored and introduced the bill during the last legislative session. We are working with the Title VIII Coalition and Medical Society (MSSNY) as a priority for the next legislative session. The NYSCA Legislative committee provides the most updated information happening in Albany.

Can NYSCA request insurance companies have Chiropractic specific representatives with direct contact information? Calling the general phone line is cumbersome with representatives that are not knowledgeable about specific benefits and reimbursements.

A: This is an excellent idea. Although insurance companies should train their billing representatives in all professions and their benefits, we know in practice that's not true. Insurance companies that already have specific representatives do not publish their contacts to avoid being inundated with practice issues. Numerous plans and regional reimbursement regions around the state make these positions difficult to fill. There tends to be a high turn over in those positions as well, so keeping up-to-date contact information is another challenge. Many issues are related to improper diagnosis codes, billing codes, or modifiers. If there is a systemic problem, then NYS DFS has a website where complaints are logged against insurance companies. The NYSCA Insurance committee works tirelessly to facilitate communications with the insurance companies. They are an excellent member benefit and resource when a recurrent issue arises.

2023 End of Session Update

New York's legislative session was scheduled to end on Thursday, June 8; however, both houses remained in session into the weekend. The Senate finished around 3:30 a.m. on Saturday, June 10th. The Assembly worked until Saturday at 4:30 p.m. but then adjourned without concluding their business. The Assembly returned on June 20th to wrap up remaining issues and concluded their business late in the evening of June 21. This session was limited in scope, mainly focusing on passing local bills.

The end of the 2023 legislative session was greatly impacted by the delay in passing the State budget, which was due by Saturday, April 1, but was not passed until Wednesday, May 3. This delay created a truncated end of session in Albany. Unlike in prior years, where the end of session included a flurry of legislative activity on major policy issues, the 2023 legislative session ended on a quieter note. The delay in finalizing the State budget meant that the normal eight-week end of session period was shortened to four weeks. As a result, true momentum could not be gathered for large-scale legislative priorities that we tend to see at the end of a legislative session.

Regarding NYSCA's legislation generally, we are actively tracking nearly 200 bills that would impact Association members. 34 new bills of interest for NYSCA were introduced in 2023 alone. In the end, nine bills we are tracking passed both houses. These standalone bills are separate and apart from the legislation and initiatives included in the State budget.

Below, please find a summary of the main issues of note for NYSCA.

Budget Initiatives

• Transfer of Oversight of Licensed Healthcare Professionals This proposal would have moved the oversight and licensure of all healthcare professionals, including the chiropractic profession, from the State Education Department to the Department of Health. This proposal was also in the Governor's budget last year and was ultimately removed, the same as this year. NYSCA did not take a formal position on which agency should have oversight of the professions, but we made known that whoever has oversight of the professions needs more resources and staff to meet the licensing and regulatory needs of the professions.

Bills Passed Both Houses

• Athletic Trainer Scope – S942-A (Bailey)/A219-A (Solages) This legislation, which NYSCA supports and has been a priority for the athletic trainers for over a decade, would update the scope of practice for athletic trainers. Importantly, this proposed scope of practice update ensures that supervision under a physician remains a priority and will allow physicians and athletic trainers to work together. NYSCA supported this legislation because New York must continue to work to review and update the scope of practice for all licensed health care professionals. All health care professionals should be able to practice to the full extent of their education and training. This is in the best interest of the patients in New York State to ensure that they have access to providers and care in a timely and appropriate manner. If signed by the Governor, it will go into effect in two years.

• Health Care Practitioner Affirmation – S2997 (Rivera)/ A6065 (Dinowitz)

This bill, which NYSCA supports, would allow health care practitioners to serve or file affirmations in court with the same force and effect as an affidavit. Further, the bill broadens who may issue such affirmations. Previously, only physicians, osteopaths, or dentists could file affirmations. This bill would change that to any health care practitioner licensed under Title 8 of the Education Law. This bill has been around for a decade and has finally passed both houses. If signed by the Governor, this bill would take effect immediately.

Physical Therapist Education Requirements – S6220-B (Stavisky)/A6696 (Fahy)

While we did not actively take a position on this legislation, we have been monitoring it. This legislation would require physical therapists to receive a doctoral degree in physical therapy. The bill would not impact the validity of existing licenses and permits for physical therapists. Since 2006, all New York physical therapist educational programs have required a clinical doctorate degree. This legislation updates New York law to more accurately reflect the educational standards of the profession. The bill would take effect one year after it is signed by the Governor.

NYSHIP The Empire Plan

Enrollee benefits have changed for certain groups in The Empire Plan eff ective July 1, 2023. We have included information relative to massage therapy and acupuncture, for those NYSCA members who provide these services in their office. Please note: The New York State Health Insurance Program (NYSHIP) Empire Plan for NY state and local government employees is not Empire Blue Cross Blue Shield.

Elimination of multiple participating provider copayments per visit

The \$25 participating provider copayment amount remains the same, with multiple copayments for the same provider and same visit eliminated. Just one copayment of \$25 is required for all covered office visits, office surgery, radiology and/or laboratory services received by the same enrollee from the same provider on the same date of service. Historically, NYSHIP enrollees who received radiographic services in addition to an office visit during the same visit were subject to two copayments.

Change in maximum allowed amount for nonparticipating providers

Claims from nonparticipating providers will now utilize Medicare rates as the fee basis. For those NYSCA members who do not participate with The Empire Plan, your NYSHIP patients may be responsible for a higher portion of the visit. Note that participating providers should continue to refer patients to network providers in accordance with contractual obligations.

Visit limit added for out-of-network acupuncture services

Coverage is now limited to a maximum of 20 visits per calendar year for acupuncture services by nonparticipating providers. This is a combined total for all nonparticipating providers, regardless of how many nonparticipating providers are visited.

Visit limit added for massage therapy services

Coverage is also limited to a maximum of 20 visits per calendar year for massage therapy services. This is a combined total for all massage therapy visits, regardless of how many providers are visited.

New Advance Beneficiary Notice in Effect for Medicare on June 30, 2023

An updated Advance Beneficiary Notice of Non-Coverage (ABN) form CMS-R-131 was approved by the Office of Management and Budget (OBM) with an expiration date of January 31, 2026, to be used for Medicare patients. The notice is a helpful tool to shift the liability on payment responsibility to the patient to notify them of their responsibility for payment. Providers should be aware of when and when not to use the form. Incorrect timing, frequency, or use may result in providers issuing refunds or facing sanctions. Since Medicare has limited coverage for services provided, this is a perfect opportunity to introduce the patient to the benefits of ChiroHealthUSA and the discounted prices available through this program.

The ABN form CMS-R-131 is a Medicare and Medicaid form when the Medicare payment is expected to be denied. The form is viewed as a limit on liability for providers and patients alike. Last year the government mandated the No Surprise Act, which required that patients be informed of their responsibility to pay for services before they are rendered. The provider issues a "Good Faith Estimate" to the patient to inform them of the expected cost for goods and services spanning up to one year. However, in most instances, the Good Faith (GFE) is not to be used for Medicare or Medicaid. The GFE is the non-Medicare version of the ABN form.

Suppose you anticipate that a service statutorily covered by Medicare will not be covered. In that case, The ABN form is mandatory for covered services but voluntary for non-covered services. As with any documentation requirements, it never happened if it is not documented. The ABN form is your documentation that the patient has been informed of your determination of likely service non-coverage. It gives the patient the choice to have the service or not and whether to have the provider file a claim for the service denial.

Workers Comp Claims Show Chiropractic Care Associated with Lower Cost and Faster Return to Work!

Despite being experts in lower back pain, chiropractors are often overlooked when it comes to workers' compensation claims in states where the insurance company or employer directs who the employee sees for an injury. However, a report issued by the Workers' Compensation Research Institute (WCRI) shows that employees, employers and insurers could all benefit from increased utilization of chiropractic care.

Researchers with the WCRI reviewed over two million claims from 28 states, including TN, where the injury occurred between Oct. 1, 2015 and Sept. 30, 2017. After excluding claims involving conditions such as tumors and fractures, they assessed both cost and claim duration and compared the differences between workers who received only chiropractic care, those who received a combination of chiropractic and other types of providers and those whose care did not involve any chiropractic care.

What they observed indicates chiropractic care as a primary treatment for low back injuries can be good news for all involved! Table 4.5 on page 47 of the 122 page report displays the comparisons. (Note: Indemnity costs refers to the costs of defending or prosecuting suits or claims in a lawsuit. This includes attorney fees, consultants fees, expert witness fees and other costs associated with the lawsuit.)



Doctor Struggles with Patient Noncompliance

Both doctor and patient play important roles in obtaining good outcomes. Should the doctor cede control of the care approach?

Leah Harms, a 44-year-old pharmaceutical researcher and consultant, first presented to William Westoff, DC in July 2018. Leah reported symptoms of back pain that began after her dog suddenly yanked on the leash during a walk. Leah brought with her an MRI from 2015 that revealed an L5–S1 bulging disc with desiccation.

At Leah's first visit, Dr. Westoff determined treatment by feeling the joints and paraspinal muscles for tone, inflammation, swelling and intersegmental joint restriction. He also used global biomechanics, patient range of motion, and tests to assess muscle and joint integrity. He tested orthopedically and by checking Leah's deep tendon reflexes. These findings were normal. Because Dr. Westoff did not typically record negative/normal findings, they were not documented.

From his evaluation, Dr. Westoff found weakness in Leah's left soleus and the musculature in her lower back. He found no atrophy or dysfunction. Her deep tendon reflexes of the upper and lower extremities were within normal limits.

Through various testing, Dr. Westoff identified that Leah's left quadriceps muscle and range of motion were not within normal limits. She had positive findings on the Nachlas and Yeoman's Tests, as well as on the straight leg raise at 80 degrees.

However, because Leah had no loss of reflexes, atrophy of the extremities, nerve root tension signs or extreme pain, Dr. Westoff didn't believe she needed a follow-up MRI. Dr. Westoff determined the causes of her left-sided sciatic pain were multifactorial and included Leah's weight gain, history as a cigarette smoker, driving several times a week for 10–14 hours per day, and the previously diagnosed lumbar degeneration and desiccated bulging disc. Dr. Westoff believed the source of the sciatica was the L5–S1 disc, and it would only worsen over time. However, he did not communicate this to Leah.

REVISED FORM I-9 FOR US EMPLOYERS

On Aug. 1, 2023, the U.S. Citizenship and Immigration Services (USCIS) published a revised version of Form I-9, Employment Eligibility Verification (PDF, 899.28 KB). Form I-9 is used to "verify the identity and employment authorization of individuals hired for employment in the United States. All U.S. employers must properly complete Form I-9 for each individual they hire for employment in the United States. This includes citizens and noncitizens. Both employees and employers (or authorized representatives of the employer) must complete the form." (USCIS)

The USCIS has stated that "employers can use the current Form I-9 (edition date 10/21/19) through Oct. 31, 2023. However, starting Nov. 1, 2023, all employers must use the new Form I-9."

Opioids No Better for Acute Neck and Back Pain Than Non-Opioid Treatment

— Australian trial finds no difference in pain scores over 6 weeks by Sophie Putka, Enterprise & Investigative Writer, MedPage Today

No significant difference was found in pain scores for opioid analgesics versus placebo for acute lower back or neck pain, the Opiates and Pharmacology clinical trial found.

At 6 weeks, mean pain scores on a 10-point scale were 2.78 in the opioid group versus 2.25 in the placebo group (P=0.051), Chung-Wei Christine Lin, PhD, of the University of Sydney in Australia, and co-authors reported in The Lancet.

Both groups received guideline-recommended care, including non-steroidal anti-inflammatory drugs (NSAIDs). Adverse events were similar in the two groups (35% in the opioid group and 30% in the placebo group, P=0.30).

"This trial has clearly shown there is no benefit to prescribing a short course of an opioid medicine for pain management in people with acute back or neck pain, and in fact, it could cause harm in the long-term even with only a short course of treatment," co-author Andrew McLachlan, PhD, also from the University of Sydney, wrote in an email to MedPage Today.

As many as two-thirds of Australians are prescribed opioids when they present with lower back and neck pain, despite clinical guidelines recommending them as a last resort, the authors noted. In the U.S., a study using data from 2013-2016 found that 32.3% of patients visiting the emergency department for acute lower back pain were prescribed opioids. In 2022, the CDC changed its opioid prescribing guidelines for acute, subacute, and chronic pain.

"The OPAL trial is a single trial, but it raises serious questions about the use of opioid therapy for acute low back and neck pain," wrote Mark Sullivan, MD, PhD, and Jane Ballantyne, MD, of the University of Washington in Seattle, in an invited commentary.

One explanation for the study's findings could revolve around the definition of chronic versus acute pain, they suggested. Participants were required to have only 1 month pain-free prior to their current pain episode, they noted.

"If many of these participants had recurrent pain, this might account for the non-response to opioid therapy," Sullivan and Ballantyne wrote. "Low back pain has been reported to transform over a year from a more sensory and nociceptive pain problem to one that is more emotional and nociplastic"

In December, we sent an update regarding an amendment to New York State's existing law on nursing employees and breastfeeding accommodations. This law became effective on June 7, 2023, so employers should take note of several new obligations and ensure they are in compliance.

Change: The New York State Department of Labor has issued a written policy regarding the rights of nursing employees to express breast milk, as well as two new sets of FAQs. Employers must provide the state-created policy to each employee upon hire and annually thereafter, and to employees upon returning to work following the birth of a child.

He was named "Chiropractor of the Year" and received a Pioneer Award for his "vigor, courage and perseverance in paving the path and protecting the profession" from the New York State Chiropractic Association.

He also received a Centurion Award from his alma mater, the Palmer College of Chiropractic, for "professional leadership, community involvement and the support of student-alumni activities".

He held leadership positions with the Regents of the University of the New York State Board for Chiropractic, the New York State Board of Chiropractic Examiners, the Erie County [NY]] Medicaid Assistance Program, the New York State Chiropractic Association, the Kiwanis Club of Buffalo, and the United States Army, where he served as a first lieutenant.

Affectionately known as "Dr. Bob", Dr. Conschafter graduated from the Palmer College of Chiropractic, Bowling Green State University and Amherst [NY] High School.

His passion for and love of chiropractic, his quiet leadership, his compassion and empathy and his firm handshake will be missed, especially by the thousands of people he guided to health and happiness in his 62 years of practice. Former NYSCA President, Jack Stuart Beige, DC, Esq. Passes Away.

Jack Stuart Beige received his Doctor of Chiropractic in 1966 from New York Chiropractic College and his Juris Doctor from Touro College Jacob D. Fuchsburg Law Center in 1993. He had a thriving chiropractic practice from 1966 through 1988 when he began his law studies.

He was appointed to the Workers' Compensation Board by Governor Mario M. Cuomo in 1984 and served in that post until 1990. During that time he was instrumental in expanding the role of the chiropractor in the treatment of injured workers. He was instrumental in the execution and passage of three (3) bills before the New York State Legislature - Chapter 800 of the Laws of 1990 (Confidentiality Law); Chapter 683 of the Laws of 1991 (Nutrition Law) and help secure enactment of Chapter 426 of the Laws of 1997 (Insurance Equality Law). As an attorney, he successfully represented accident victims with his unique understanding of the mechanics of injuries.

Dr. Beige served as Vice President of the New York State Chiropractic Association (NYSCA) from 1983 through 1987 and was elected President of the NYSCA from 1987 through 1988 when he was admitted to the Touro College of Law. Dr. Beige was the recipient of many accolades, honors and awards conferred upon him by the State Association, including the Ernest G. Napolitano Award, the Association's highest award, in recognition of all of Dr. Beige's years of dedicated service to the profession. A life-long chiropractic warrior, Dr. Beige continued to support the Association and attend NYSCA functions and meetings throughout the years right up to the time of his passing.

Dr. Beige was a guest lecturer at New York Chiropractic speaking on "Ethics and the Law" and has continued to represent clients before the Office of Professional Discipline. More recent, Dr. Beige represented businesses and individuals who had delinquent tax issues with both the Internal Revenue Service and New York State Department of Taxation & Finance. He effectively negotiated Installment Payment Agreements, Offers in Compromise and assisted in giving clients financial peace of mind.

He was a member of the American Society of Tax Problem Solvers and was admitted to practice before the United States Tax Court.


